ORDER

Provisional affiliation was granted to Farook B.Ed. College (Unaided), Kottakkal, P.O. Parappur, Malappuram (Dist) for starting B.Ed. Degree Programme during the academic year 2004-05 with an intake of 100 students with permission to start classes during 2005-06, vide University Order read as 1st.

2.Vide paper read as 2nd, the National Council for Teacher Education, Southern Regional Committee, Bangalore, has permitted Farook B.Ed College (Unaided), Kottakkal, P.O. Parappur, Malappuram (Dist), for conducting B.Ed degree programme of two-year duration with an annual intake of 50 students [one basic unit] from the academic year 2015-16.

3. Vide U.O read as 3rd the Syndicate has resolved to grant continuation of provisional affiliation to each batch of Teacher Education Colleges at the beginning of the course keeping the existing formalities without insisting orders for extension of approval from NCTE in every year.

5.The Principal, vide paper read as 4th, has requested to grant Continuation of Provisional Affiliation to the B.Ed degree programme for the academic year 2023-24, after remitting the required fee towards affiliation.

6. Continuation of Provisional Affiliation to the B.Ed Programme for the academic year 2022-23 was granted vide University Order read as 5th. The Principal has submitted renewal of NOC from Govt, vide paper read as 6th.

7.Considering the above, sanction has been accorded by the Vice Chancellor for granting continuation of provisional affiliation to the B Ed programme with the following optional for the academic year 2023-24 at
