**ORDER**

Provisional affiliation was granted to Farook B.Ed. College, Kottakkal, P.O. Parappur, Malappuram (Dist) for starting B.Ed. Degree Programme during the academic year 2004-05 with an intake of 100 students with permission to start classes during 2005-06, vide University Order read as 1<sup>st</sup>.

2.Vide paper read as 2<sup>nd</sup>, the National Council for Teacher Education, Southern Regional Committee, Bangalore, has permitted the college for conducting B.Ed degree programme of two-year duration with an annual intake of 50 students [one basic unit] from the academic year 2015-16.

3. Vide U.O read as 3<sup>rd</sup> the Syndicate has resolved to grant continuation of provisional affiliation to each batch of Teacher Education Colleges at the beginning of the course keeping the existing formalities without insisting orders for extension of approval from NCTE in every year.

5.The Principal, vide paper read as 4<sup>th</sup> and 6<sup>th</sup>, has requested to grant Continuation of Provisional Affiliation to the B.Ed degree programme, with renewed NOC, for the academic year 2024-25.

6. Continuation of Provisional Affiliation to the B.Ed Programme for the academic year 2023-24 was granted vide University Order read as 5<sup>th</sup>.

7.Considering the above, sanction has been accorded by the Vice Chancellor for granting continuation of provisional affiliation to the B Ed programme with the optional, as detailed below, for the academic year

- v. The Principal is directed to engage faculties having required qualifications as per the UGC regulations and in compliance to the provisions under ACT 13 of 2021 Kerala self financing college teaching and non teaching (appointment and conditions of services).
- vi. Failure to comply with any of the above will lead to withdrawal of affiliation.
