ORDER

Provisional affiliation was granted to Farook B.Ed. College (Unaided), Kottakkal, P.O. Parappur, Malappuram (Dist) for starting B.Ed. Degree Programme during the academic year 2004-05 with an intake of 100 students with permission to start classes during 2005-06, vide University Order read as 1st.

2. Vide paper read as 2nd, the National Council for Teacher Education, Southern Regional Committee, Bangalore, had permitted the college for conducting B.Ed degree programme of two years' duration with an annual intake of 50 students [one basic unit] from the academic year 2015-16.

3. Vide U.O read as 3rd, the Syndicate resolved to grant continuation of provisional affiliation to each batch of Teacher Education College at the beginning of the course keeping the existing formalities without insisting orders for extension of approval from NCTE every year.

4.The Principal, Farook B.Ed collge (Unaided), Parappur P.O., Kottakkal, Malappuram, has requested, vide paper read as 4th, for Continuation of Provisional Affiliation to B Ed. Degree programme for the academic year 2025- 26. The Principal, has also requested to sanction re-allocation of seats for B.Ed optional subjects for 2025 admission(2025-27 batch) in accordance with the rules stipulated vide University Order read as 5th.

5.Considering the above, sanction has been accorded by the Vice Chancellor to grant Continuation of

Provisional Affiliation to the Self Financing B.Ed programme at Farook B.Ed college (Unaided), Parappur P.O., Kottakkal, Malappuram, for the academic year 2025-26, on a conditional basis, subject to the submission of the renewal NOC for the year 2025-26, with strict directions to engage only qualified faculty as prescribed by the respective regulatory bodies and to ensure full compliance with the provisions of ACT 13 of 2021, along with reallocation of seats among optional subjects in B.Ed programme for 2025 admission (2025-27 batch) as detailed below:

6.Orders are issued accordingly subject to the conditions specified hereunder:

- Affiliation granted is strictly provisional and only for the academic year 2025-26. The college must apply for CPA for the ensuing years by remitting the fee fixed by the University from time to time, along with the extension of approval orders, if any, from the apex bodies concerned.
- The Principal shall follow the syllabi available on the University website (www.uoc.ac.in)/ approved by the University for selecting courses.
- The courses in this order shall not be treated as a factor for calculating the workload for the subject or the requirement of teaching faculty, for which competent orders shall be obtained from the Government/University.
- Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and based on the directions issued by the University/Government from time to time.
- In the light of the directions of the Supreme Court of India in WP (C) 656/1998, the institution shall take stringent measures for the prevention of ragging in any form. In case of failure to prevent such instances of ragging, appropriate action, including withdrawal of affiliation of the college, will be initiated.
- The conduct of examinations is not permitted in colleges unless they have been granted the continuation of provisional affiliation or their application is under process.
- The conduct of University Examinations, including SDE Examinations, is compulsory and binding on all colleges affiliated with the University of Calicut.
- The college is liable to comply with the general conditions stipulated in the renewed NOC from the Govt. of Kerala for the academic year 2025-26.
- Admission to the next academic year shall be made only after obtaining prior permission from the University.
- No students shall be admitted to any course of instruction in the college in anticipation of affiliation.

Violation of any of the above conditions will lead to the cancellation of affiliation.

ORDER

As per the letter read above, the Principal, Farook B.Ed. College, Parappur P.O., Kottakkal, Malappuram has requested the Government for the renewal of NOC for conducting self-financing B.Ed. course in the college, during the academic year 2025-26.

2. Government have examined the matter in detail and are pleased to renew NOC for conducting self-financing B.Ed. course with the following optional subjects in Farook B.Ed. College, Parappur P.O., Kottakkal, Malappuram, during the academic year 2025-26.

1. English
2. Mathematics
3. Natural Science
4. Physical Science
5. Social Science

Renewal sanction of NOC is subject to the following conditions:

1. The Educational Agency shall submit the documents to prove that the College has adequate infrastructure, human and physical to conduct the course as required by the Government.
2. The Educational Agency shall abide by the procedure of admission in the college as decided by the Government from time to time.
3. The Educational Agency shall set apart 50% of the seats of the course

for being filled up by the Government or such authority determined by Government on the basis of merit and reservation principles followed by the Government and the remaining 50% filled by the Educational Agency on the basis of merit.

4. The Educational Agency shall collect only such fees as determined by the Government from time to time from the students admitted to the college for the course.

5. The Educational Agency shall institute adequate number of scholarships on merit cum means basis as determined by the Government from time to time to the students admitted to the course.

6. The Educational Agency shall appoint and fix the service conditions of the teachers and non teaching staff in the college for conducting the course as followed by Government in conducting similar courses.

7. The Educational Agency shall institute an appropriate governance structure that would ensure transparency, efficiency and social accountability in the Educational agency as determined by the Government from time to time.

8. The Educational Agency shall publish the details regarding the establishment and governance of Educational agency, admission, fees,courses,results, teaching and other staff, and any further information as required by the Government on the website of the Educational agency.

9. The Educational Agency shall run only courses approved by the Government and the University concerned.

10. The Educational Agency shall enable the Government and its representatives to check, verify and monitor the compliance of the conditions mentioned above at any time the Government so decides.

11. The Educational Agency shall enter into an agreement with the affiliating University on the terms determined by the affiliating University in respect of all or any of the matters contained in this agreement.

12. In the event of breach of any of the conditions mentioned above by the educational agency, the Government is authorized to adjudicate the quantum of compensation which the Educational agency is liable to pay to the Government, if any, and upon such adjudication, the Educational Agency shall pay to Government the amount so fixed, failing which the amount of compensation adjudicated should be recoverable under the provision of Kerala Revenue Recovery Act, 1968, as if they were public revenue due on land.

13. The No Objection Certificate granted shall be valid up to the end of the Academic year 2025-26 and renewable on the request of the Educational Agency and subject to the satisfactory compliance of the conditions specified herein.

14. In the event of the breach of any of the conditions mentioned above by the Educational agency, the Government shall also be entitled to withdraw the sanction without formal notice to the Educational Agency.

15. The Educational Agency shall produce necessary documents for the continued affiliation from the University for the year 2025-26 before 30.09.2025 failing which the sanction issued will be treated as cancelled w.e.f. 01.10.2025 and the Government will not be responsible for any loss incurred by the institution and the institution shall be solely responsible for the losses thereof.

16. The Education Agency shall seek NAAC accreditation for the institution at the earliest.

17. The Institution should invariably follow the regulations issued by the NCTE for teacher education programmes from time to time.
